One of the last survivors from the great fleet of over 2700 war-built LIBERTY SHIPS and the “Last Operational Troopship of World War II,” S.S. JOHN W. BROWN is waiting to take you on a six hour adventure back in time to the exciting and dangerous days of the Second World War when Allied convoys battled their way across the Atlantic and “Fighting Liberty Ships” carried troops and cargo to the far-flung battlefields across all the oceans of the world.

This exciting 6-hour day cruise features a continental breakfast, luncheon buffet, afternoon snacks and beverages; live big band music of the 40’s; the comedy of Abbott & Costello; barbershop music; historical reenactors, and flybys (weather permitting) of vintage World War II aircraft with the ship’s gunners manning the guns to defend the ship. The ship is open for tours including museum spaces, crew quarters, bridge, mess rooms, troop berthing and much more. Watch the magnificent 140 ton triple expansion steam engine as it powers the ship through the water.
