Travel Documents

Original, signed passport valid for 6 months beyond stay, and with at least one blank Visa page for Visa stamp(s).

Payment

A deposit of \$300 per person will confirm your reservation. Final payment due to AAA by April 30, 2010.

Cancellation Penalties

From day of deposit to day of departure	\$25 per person
From May 12 to June 27, 2010	\$300 per person, plus any additional suppliers' fees

Insurance
