### FREE PASSPORT PHOTO SERVICE

Foreign travel requires passport photos and that can be expensive. Instant passport photo service is available at your AAA office during normal business hours. AAA member rates are considerably lower than rates charged at commercial photo studios... now as an AAA North Penn Plus Member, one set of photos are free per membership year.



### \$2,000 THEFT REWARD

AAA Plus increases your protection to \$2,000 for information leading to the arrest and conviction of a person vandalizing, stealing, or causing a hit-and-run accident involving an eligible vehicle registered in the name of the AAA Plus member. Displaying your new AAA Plus Theft Reward sticker in a conspicuous location on your automobile, informs would be thieves that the world's largest motoring organization is willing to pay for information leading to the arrest and conviction of anyone stealing your vehicle.

(Claims must be submitted within 60 days of conviction. Law enforcement officers, the member, and the member's family are ineligible to receive the reward.)

**EMERGENCY ROAD SERVICE BENEFITS**



**EXTENDED DISTANCE TOWING**

AAA Plus extends your present AAA membership by providing a total of up to 100 miles of towing in any direction from the point of disablement to a destination of your choice. (one tow per disablement) This expanded benefit includes the use of equipment, such as dollies, wheel lifts, or flatbed trucks, if such equipment is necessary to safely tow the eligible vehicle.



**AAA PLUS RV**

AAA Plus RV extends present AAA Plus benefits to include motor homes, fifth wheel trailers, pickups with campers, travel/utility trailers, and motorcycles. *AAA Plus RV is not a part of basic AAA Plus. It must be purchased separately.*



**FUEL DELIVERY SERVICE**

AAA Plus provides, at no additional cost, a sufficient amount of fuel to enable the member to reach the nearest service station. If this service fails to make the vehicle operable, the extended towing benefit will apply.



**LOCK AND KEY SERVICE**

AAA Plus provides added coverage for reimbursement up to a total of \$100 in parts and labor for lock and key service if required either to gain access or make the eligible vehicle operable.



**EXTENDED EXTRICATION SERVICE**

AAA Plus extends coverage to include the delivery of services by a second truck and operator for one (1) hour at the scene of disablement. If the vehicle is unable to be operated after extrication, the extended towing benefit will apply.



**REIMBURSEMENT AT COMMERCIAL RATES WHEN AAA SERVICE UNAVAILABLE**

If AAA service *is requested and is unavailable* at the place of disablement, AAA Plus coverage extends your protection to include reimbursement at commercial rates for AAA Plus services you obtain from a commercial facility nearest your location. The reimbursement benefit will apply to all emergency road services except lock and key service which is covered up to \$100 under the AAA Plus Lock and Key Service Benefit.



**TRIP INTERRUPTION REIMBURSEMENT**

In the event of a *collision* which occurs while driving an eligible vehicle 100 miles or more from home, AAA Plus provides reimbursement up to \$700 for lodging, meals, or alternate transportation, incurred within 72 hours, if your trip is delayed for 24 hours or more. Please save your itemized bills (in member's name only) and submit with the claim form and police report within 30 days of the incident and if covered, a reimbursement will be promptly forwarded to you.



**LEGAL REIMBURSEMENT BENEFITS**



**UP TO \$1,500 IN LEGAL REIMBURSEMENT PROTECTION**

AAA Plus provides reimbursement of attorney's fees for defense of vehicle related charges to which you plead not guilty, and covers any AAA Plus member who is driving a vehicle eligible for service under the basic membership at the time such charges are incurred. Charges covered under this benefit and the reimbursement schedule are listed below:

Vehicular manslaughter or negligent homicide . . . .	\$1,000
If appealed, not more than . . . . .	\$500
Reckless driving or endangerment . . . . .	\$400
If appealed, not more than . . . . .	\$200
Moving violations covered by traffic ordinances . . . .	\$100
If appealed, not more than . . . . .	\$ 50

NOTE: Legal reimbursement protection does not apply to violations involving driving while under the influence, or driving on a suspended or revoked license/registration.
